Subject: **WIPO: Young Experts Program (YEP)**

The World Intellectual Property Organization (WIPO) has launched a two-year Young Experts Program (YEP). WIPO Secretariat's detailed notice is attached.

2. The program is aimed at tapping young talent from developing, least developed countries and countries in transition selected and to train them in the technical and policy aspects of IP. Through this program, participants would be trained to contribute to the development of innovation and creative ecosystems of their respective countries and regions.

3. To be eligible to apply, candidates must fulfil the following:

- first-level university degree;
- have at least 2 years of relevant experience, desirably in the area of Intellectual Property and project management;
- be available to participate in the two-year program 2023-2024;
- possess excellent knowledge of written and spoken English; and
- possess excellent interpersonal skills and the ability to establish and maintain effective partnerships and working relations in a multi-cultural environment.

4. Young Experts would receive a monthly stipend of 5,000 Swiss Franc (CHF). WIPO would provide also medical and accident insurance coverage during the course of the program. Contribution toward travel expenses would also be provided by WIPO. If necessary, WIPO may provide assistance in obtaining an entry visa to Switzerland. The experts would be responsible to find and pay for their own accommodation in Geneva.

5. The application process has opened on 14 September 2022 and close on 5 October 2022. It may be noted that application process is through direct applications by candidates and not through a national nomination process. YEP selectees will enjoy a wide-ranging and cohesive WIPO working experience, focused on on-the-job learning and exposure to different sectors, focus areas and colleagues. The YEP will also include regular networking opportunities with top and senior leadership at WIPO.

The selected Young Experts will be allocated to assignments in accordance with organizational needs and priorities and based on the profile and expressed interest of the candidates.

c. Reporting Lines

The Young Expert will be assigned a direct supervisor and be under the general guidance of the relevant Sector Lead.

The Young Expert will work with colleagues in Divisions and Departments across the whole of WIPO, as well as external partners.

In the Copyright Management Division, you will assist in preparing and implementing technical assistance projects, initiatives and tools, to the benefit of WIPO Member States and CMOs worldwide.

In Year 1 you will participate in the development and distribution of externally focused content on WIPO's social media channels and be involved in other communications projects. You will acquire a broad understanding of WIPO and how to effectively communicate on complex technical issues in layperson style, on different platforms and through a variety of communications assets. This will prepare you for Year 2 where you will acquire an in-depth understanding of how WIPO interacts with its government stakeholders. In 2023/24, two diplomatic conferences are expected to culminate in two new international treaties. You will be closely involved in the organization of these high-level diplomatic events.
